Journal Publishing Rules

1. The "*Egyptian Journal of Science Education*" (EJSE) publishes original and solid theoretical and applied research articles in the field of science education. Papers should reflect distinguished academic level, so that they constitute a new and unique contribution in the field of science education. Papers should be written in either Arabic or English language.
2. The journal accepts the summaries of university theses, and reviews of new books in the field of science education, whether in Arabic or in English.
3. All files of the paper are sent and received by the editor-in-chief via the electronic system of the (EJSE) page on the EJSE website of the Egyptian Knowledge Bank (EKB); where the author should register at the journal's site at the following link: <https://mktm.journals.ekb.eg>, and create a personal page for him/or her as an author on the journal's web page. Papers sent via e-mail to the editor-in-chief or members of the editorial board will be discarded.
4. Research and studies submitted to the journal are subjected to examination and review based on the rules of the peer review process indicated in the journal, by the editorial board and two members of the jury for each paper.
5. The researcher should adhere to the scientific method in writing the research article so that it is characterized by good organization, accuracy, free of linguistic errors, accuracy, and reliability of documentation. The research article should show clarity of assumptions or ideas, design strength, sample representation of the study population, clarity of research methodology using research methods compatible with empirical design variables and data collection tools, whether qualitative or quantitative. The research article should be clear about appropriateness of statistical methods, their application

in a precise manner, objectivity and credibility of conclusions, and novelty of resources.

6. The researcher must adhere to the rules of publishing ethics as to avoid direct plagiarism, falsification and fabrication of results, and the submission of the article in more than one journal, in more than one language at the same time, and write the names of authors who did not participate in the research article. Researchers should write the names of all authors who participated actually in the research work. Researcher should provide acknowledgments-when submitting the research article to the EJSE- that his/ or her research work has taken into account the rules of integrity and scientific ethics, and that it has not been published or presented in any other local, Arab, regional or international journal before submission to the EJSE.

7. All copyrights and their consequences devolve to the publisher, the *Egyptian Society of Science Education* (ESSE).

8. After publication, the researcher gets one hard copy of the journal issue, and five print-outs for his research.

9. The researcher, whether Egyptian or non-Egyptian, shall bear the costs of review, whose value is (600) Egyptian pounds. The cost of printing and publishing for (30) pages is (1200) Egyptian pounds according to the rules specified by the EJSE. In the case that the printed research article exceeds 30 pages- up to 50- one extra page will cost (40) Egyptian pounds. Costs will be deposited by the researcher in the account of the publisher "The Egyptian Society of Science Education (ESSE): in the *Bank of Alexandria*, Roxy Branch: The account number for Egyptian pounds is: (120000769002); and the account number is: (120000769001) for US Dollars.

10. The *writing* of the research article should comply to the following specifications:

- The researcher should to use the Arabic numerical system (1, 2, 3, 4, ...) in writing any number included in the body of the research article i.e. tables, figures, and appendices.

- The research article is written in a “Word” file. Page dimensions (17.5 × 25), and should be no more than 50 pages including references).
 - Leave one space between lines in the body of the research article, a space and a half between the main title or subtitle and the beginning of the next paragraph, and a space and a half between paragraphs.
 - Top margins top 2.1 cm, bottom 3.16 cm, right 3.1 cm, left 2.75 cm.
 - Header margins 1.16 cm and the footer margins is 1.27 cm.
 - The researcher is required to write the research article using Times New Roman font, (whether for Arabic or English), with size: 14 Bold for headings, 13 Bold for subtitles, 13 for the body, 13 for headings of tables and figures, 12 for abstract content in both languages, and for tables' content, and 12 for the reference list.
 - No information should be entered in the “Header” or “Footer” of the pages of the search article. Pages are not numbered, and the author should not write his/ or her name, job, or contact information on the first page under the title of the article. Headings and subheadings are not numbered in the article's body.
 - A separate “Word” file should be attached to the research article's file that should include the author's data: the author's name, academic degree, employer, e-mail address, and website address.
- 11.** An abstract of the research article should be provided in Arabic, and another (Abstract) in English, not exceeding 150 words, and it must include purpose of the research, research methodology, sample, tools, results, and the most important recommendations. It is written in continuous sentences without including numbered bullets. Six keywords should be attached to the research article.
- 12.** In the case of publishing a research derivative of a research project funded by a research agency, university, scientific association, or academic body; it is imperative that the

researcher be committed to publishing the name of the funding agency and the year of funding. A space is devoted to this information before the reference list under the heading "Funding".

13. The researcher can write a word of thanks to the funder (if the funding agency requires mentioning of thanks in the body of the published research article), before the reference list under the title "Acknowledgment".

14. The researcher is obligated to follow the American Psychological Association (APA-7) in documenting the references in the body of the research article, and the final reference list.
